Ordinance 2020-2021-01

An Ordinance establishing salaries

WHEREAS, The President and Board of Trustees shall set salaries for appointed officials and employees, and

WHEREAS, the President and Board of Trustees shall set the pay schedule of all appointed officials and employees,

NOW, HEREBY BE IT ORDAINED, BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FAIRMOUNT, ILLINOIS as follows:

## ARTICLE 1: Pay Schedule

### Section 1: Hourly employees

Hourly employees shall be paid twice a month, on the 15<sup>th</sup> of the month and the last day of the month. If either of these days fall on a Saturday, Sunday, or holiday, the checks will be delivered on the prior weekday before said Saturday, Sunday, or holiday.

### Section 2: Salaried employees or appointed official

Salaried employees and appointed officials shall be paid once or twice per month, depending on their choice. The pay dates shall be the same as for hourly employees listed above.

If a salaried employee or appointed official does not work the entire month, their salary for the month shall be determined by dividing the annual salary by 365 and multiplying by the number of days in that month they were employed.

## Article 2: Pay Rate

The pay rate is listed in the Pay Rate table attached as a part of this ordinance.

ARTICLE 3: Conflicts

This ordinance shall take precedence over any prior ordinance or resolution used to set salaries for the Village of Fairmount

Section 4: Effective date

The effective date for salaries set by this ordinance shall be May 1, 2020.  
Standing Committees

This ordinance shall be in full force and effect immediately after its passage and approval.


