2020 Annual Tax Levy Ordinance

Annual Tax Levy ordinance for the levy and assessment of taxes for 2020, of the Village of Fairmount, Vermilion County, Illinois.

Hereby be it ordained by the President and Trustees of the Village of Fairmount, situated in Vermilion County, Illinois:

In pursuance of authority vested in them by "The Illinois Municipal Code of 1961", as amended, the President and Board of Trustees in meeting assembled, do hereby find and declare that there will be required to be raised by general taxation the amounts hereinafter set down, to be levied upon all taxable property in said Village, in order to meet and defray all necessary expenses and liabilities of the Village as required by statutes or voted by people in accordance with law, and the amounts so required are itemized and needed for uses and purposes as follows:



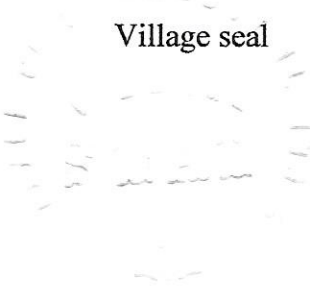


